Labelled "insuretech", Assurance and Supers such as California-based Health IQ and Hylover Health have drawn eyes over the past Baear with disruptive models that use data be unching and artificial intelligence to boost S. venue and cut costs.

No Andrew Sullivan, who heads Prudential's tirement and group insurance businesses, said a call with analysts that Assurance brought ith it 17 million customers in need of insurice."We know that there are large middle mart and mass affluent customer segments that we been traditionally underserved.

Assurance will add a new earning stream Prudential that is not sensitive to equity arkets, interest rates and credit, he said.
